Please be sure to review the Rules & Regulations. Please remember that no one under the age of 18 is allowed in the ADULT POOL area at any time. In addition, pets are not allowed within the pool area. Your cooperation is appreciated!

Complex Painting Project

The painting project will begin shortly. Prior to painting, various wood repairs will take place. Once your area is ready, the painters will use power-washers to clean and prepare for the paint application. Please be sure to bring in personal items located on your patios or balconies. Fireworks

Please remember that fireworks are not permitted anywhere in the City of Orange. This includes La Veta Monterey. Residents are encouraged to contact the Orange Police at 714-744-7444 if you see the use of fireworks on our property.

Reporting GAS Leaks

If you smell gas, you need to report it **IMMEDIATELY!** Call Huntington West Properties at 714-891-1522 and **PRESS 4** to be connected to an operator 24 Hours a Day/7 Days a Week. Please be ready to provide a location of the suspected leak, your name & unit number, and phone number. Huntington West will call COAST PLUMBING to make the necessary investigation and repairs. If a repair is necessary, the gas main will be shut off to the entire complex. This will shut off ALL 43 water heaters and furnaces to all 212 units. Once the repair has been completed, please allow at least two hours for the water heaters to produce hot water. It is advised that you DO NOT call the Gas Company since they will NOT repair the leak. They will simply red tag the pipe for repair. If you feel that you need to call the Gas Company, PLEASE call Huntington West and follow the same procedure above. If you do not call Huntington West, there could be a delay in making the necessary repairs and create a serious inconvenience for all residents at La Veta Monterey. Your diligence is appreciated!
